

2. JOB SUMMARY/JOB STATEMENT

The jobholder is responsible for activities related to fisheries management including supporting the implementation and update of the basin-wide fisheries management and development strategy. In collaboration with other specialists in the Division and with other Divisions, he or she will contribute to the MRC Indicattor framework, basin-wide assessments, studies, surveys and researches related to fisheries issues required by other specialists and Divisions.

3. MAIN TASKS AND RESPONSIBILITIES

Under the management direction of the Division Director and technical advice of the Chief Environmental Management Officer, the incumbent performs the following duties:

- Coordinate activities related to fisheries management including supporting the implementation and update of the basin-wide fisheries management and development strategy and its project based action plan;
- Provide technical support to the Member Countries in the implementation of the fisheries strategy, action plan, technical guidance including capacity building and promotion of fisheries management and governance;
- Review and document lessons learned from inland capture fisheries management and development including aquaculture;
- Develop and update relevant technical guidance or guidelines for fisheries management and provide technical support in the implementation of such technical guidance or guidelines;
- Provide technical support to MRC indicator framework, basin-wide assessments, studies, surveys and researches related to fisheries required by other specialists and divisions;
- Work closely with the Ecosystem & Wetland Specialist and the Agriculture and Irrigation Specialist on issues related to fisheries aspect of wetland and ecosystem management including agriculture and irrigation development;
- Work closely with the Fisheries and Aquatic Officer in ensuring that the monitoring activities in fisheries and other relevant environmental parameters serves the objective of fisheries management;
- Contribute to the development of relevant technical guidelines as led by other specialists / divisions;
- Coordinate and support the work of the MRC's regional technical/expert group related to fisheries management (if applicable), and contribute to the work of other regional groups as required;
- Ensure that relevant knowledge and products developed by the MRC are available at the national level to assist decision-making processes;
- Provide relevant technical inputs to the assessments of risks and impacts of decisions on water resources management and development in the basin; and
- Perform other relevant tasks as required by the superviors.
